#### I. General Information

**Humantxt.io Tool**: is an artificial intelligence based tool that enables the modification of text generated by artificial intelligence into text more similar to text created by a human, allowing for its export from an editor. However, the tool does not guarantee adequacy in relation to the recipient or context. Its functionality will be described in separate regulations.

**GDPR or Regulation**: Refers to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, repealing Directive 95/46/EC (General Data Protection Regulation).

#### II. Purposes and Legal Basis for Processing Personal Data

The Data Controller processes personal data for the purposes necessary to receive information about the **Humantxt.io** Tool to the indicated e-mail address, resulting

from your consent (pursuant to Article 6 sec. 1 letter a) of the GDPR) to subscribe to the Waitlist.

The Data Controller processes personal data to the extent necessary for:

- fulfilling legal obligations, particularly resulting from tax regulations and the accounting act, under Article 6 sec.1 letter c) of the GDPR;
- establishing or defending against claims, as well as within the Data Controller's legitimate interest, under Article 6 sec. 1 letter f) of the GDPR.

Your personal data is processed based on the consent you have given, as per Article 6 sec.1 letter a) of the GDPR. The Data Controller may process the following categories of personal data: name, surname, company, address, email address, and other data provided by you.

## **III. Data Recipients**

Your personal data may be shared with entities authorized under the law or contracts concluded with the Data Controller, including business and commercial partners such as telecommunications providers, postal operators, carriers, companies printing correspondence or managing correspondence, document archiving companies, technical service providers (e.g., for developing and maintaining IT systems and online services), legal or accounting service providers.

#### IV. Data Transfers to Third Countries

Specifically, until consent for data processing is withdrawn, legitimate interests pursued by the Data Controller cease to exist, or an objection to data processing is raised, where such an objection must be considered under the law, the data retention period required by applicable law expires, but not less than the limitation period for claims arising from the legal relationship under which the data is processed.

#### **VI. Your Rights**

Under the GDPR, you have the right to:

- 2. Amend (correct) your data.
- 3. Delete your data by the Data Controller.
- 4. Restrict your data processed by the Data Controller.
- 5. Object to the processing of your data.
- Lodge a complaint with the supervisory authority responsible for personal data protection — in Poland, the President of the Office for Personal Data Protection (ul. Stawki 2, 00-193 Warsaw), or the relevant supervisory authority in another EU Member State.
- 7. Withdraw consent for data processing, where the processing is based on your consent, without affecting the lawfulness of processing carried out before the withdrawal.
